- Teams are to check in with the BBQ Contest Coordinator upon arrival.
- All uncooked meat shall be inspected prior to any preparation or cooking.
- Teams are required to cook within their assigned space.
- Team Entry fee is \$125.00 per team and sample meat requirements listed below. Teams will be returned \$75.00 of entry fee upon completion of the BBQ event to reduce the participants out of pocket for sample meat cost. Sample meat requirement must be met prior to refund.
- Contestant agrees to comply with event rules and judging procedures.
- All cook sites must be cleaned and vacated by 7:00 PM.
- No food items are to be sold to the public by BBQ Teams during this event.

**Sample Meat Requirements for voting: Must meet one for refund, but more samples = more votes.**

- Four (4) / ( 6 to 7 LB) pork shoulder /Butt roast for judging and public samples.
- Chicken (of choice) 5 LB finished deboned meat for judging and public samples.
- Ten (10)LBS. of beef of choice for judging and public samples
