- Entries will be limited to Twenty (20) teams on a first come basis by postmark date of entry.
- Teams are to check in with the BBQ Contest Coordinator upon arrival on-site for set up location.
- All uncooked meat shall be inspected prior to any seasoning, injection or cooking.
- Teams are required to cook within their assigned space.
- Team Entry fee is \$125.00 per team and sample meat requirements listed below. Teams will be returned \$75.00 of entry fee upon completion of the BBQ event to reduce the participants out of pocket for sample meat cost. Sample meat requirement must be met prior to refund.
- Contestant agrees to comply with event rules and judging procedures.
- All cook sites must be cleaned and vacated by 7:00 PM.
- No food items are to be sold to the public by BBQ Teams during this event.
- \*\*Distribution of \$1,000.00 Prizes will be performed at the end of the awards program.

**Sample Meat Requirements for voting: Must meet all amounts for refund, but the more BBQ samples you provide to the attendees = more votes for your team.**

- PORK: Four (4) / (6 to 7 LB) pork shoulder /Butt roast for judging and public samples.
- CHICKEN: (of choice) 5 LB finished chicken of choice, deboned meat for judging and public samples.
- BEEF: Ten (10)LBS. of beef of choice for judging and public samples
- Each team will be provided one (1) additional free pork butt for sample purposes.
